ANSI/EIA 748 Guideline Intent: "How Used"

Agencies/Services:

Industry has published a standard ANSI/EIA 748, EVMS guidelines. There are differing opinions on what the language in the guideline means for a supplier trying to implement a compliant system, and for customers to understand what to expect from a system that is compliant. The "intent" statements developed for each guideline provide a **common understanding** by defining what is expected, i.e. "the intent", a basis for verifying compliance, and describing the value for the program manager. **DCMA**:

DCMA as the DoD executive agent is tasked with reviewing suppliers systems and industry has the burden of establishing that "their" system implementation will satisfy the 32 Guidelines. The "intent" statements provide reference points for a better understanding of the ability of the system to meet basic intent each guideline during performance. The "intent" statements are not designed to constrain the application of EVM system. They are to provide common understanding, yet allow continued flexibility to make suppliers EVMS system a useful program management tool.

Industry:

Industry is responsible to establish an earned value management system in conformance with the ANSI/EIA 748, EVMS Guidelines where required to satisfy contract requirements. Establishing "intent" statements for each of the EVMS guidelines provides common understanding and basis for assessment of conformance with the ANSI/EIA 748, EVMS Guidelines, an effective EVMS implementation to achieve intended management values, and useful in verifying on-going maintenance of implementation during performance. The "intent" statements provide benefits and value in the prime-subcontract relationship as well as in a prime-customer relationship.

Provides the basis for assessment of

- * EVMS conformance with the ANSI/EIA 748 Standard, EVMS Guidelines
- * EVMS implementation that achieves intended management values
- * On-going maintenance of implementation during performance
