EVMS System Acceptance Guide

Purpose

Develop a methodology for System Acceptance that the system owner can accomplish the following:

- Understand the need for and effectively design an EVMS**
- Evaluate whether the EVMS is capable of meeting the intent of the ANSI/EIA 748**
- Implement successfully the EVMS on the requiring acquisition**
- Prepare and provide documentation that substantiates implementation**
- Obtain EVMS compliance recognition that will satisfy current and future requirements for an approved EVMS**



EVMS System Acceptance Guide IPMC 2007 Workshop Goals

- Introduce the Guide to those who may not be aware of its existence
- Determine acceptance among non-DoD (Civilian) agencies
- Determine level of use
- Determine reasons for non-acceptance or non-use



EVMS System Acceptance Guide IPMC 2007 Workshop Feedback

- Limited acceptance and use among non-DoD (Civilian) agencies
 - Of those in attendance only two agencies indicated that they have or are currently using the Guide
- Reasons cited for non-acceptance/use
 - Agency Acceptance Authority not identified
 - EVM Maturity of agency
 - EVM knowledge & experience

EVMS System Acceptance Guide

IPMC 2007 Workshop Feedback

- Other issues/concerns surfaced during the Workshop
 - Accounting considerations (Gov't accounting systems do not support an EVMS)
 - Who pays for the Compliance Evaluation Review (CER) Team?
 - Acceptance of current validations
 - Acceptance Plans by agencies
 - Development of internal organizations to conduct CERs / surveillance reviews
 - Role of CAO Council and OMB?
 - OMB follow up?



EVMS System Acceptance Guide Conclusions

- Some of the previously mentioned issues/concerns have and are being addressed by the Joint Industry/Civilian Agency Working Group
 - PMSC should continue to work these issues through the Industry/Civilian Agency Working Group
- DCMA has alleviated some agency's concerns by entering into MOUs to provide validation and surveillance support
