- Goal 2: Develop a set of collaboratively produced educational materials
- Work Teams Status (collaboratively produced educational materials):
 - Industry Roles/Responsibilities (Lead: Anna Blachman)
 - Government Roles/Responsibilities (Lead: Dianna Patterson-Williams)
 - These two work teams are currently collaborating to identify roles in each area while also identifying government/industry counter-points
 - Glossary/Dictionary (De Facto Lead: Scott Rummel)
 - Developing one for Agile WG, and will leverage that for this effort to ensure consistency across Working Groups. Plans to have initial draft to whole WG for review and comment in May 2016.

- Use government SME's for input and perspective

Contacting USG for collaboration

- Possible expansion of Handbook for both Industry and USG use
- NOTES:
 - Pocket handbook to remind PM's of the following in each section:
 - Why must they they must follow the best practice; What is the risk of non compliance
 - What is the value of the activity
 - What does <u>Great</u> look like
 - How does the customer use this activity/data
 - Short and sweet to make it easy to use
 - Organize into major sections (System Engineering, Cost Management, EVMS, Supply Chain Management, Manufacturing) and address all phases of the program life cycle
 - Plan on an electronic version; an application for iPhone and/or Android
 - Include links to take you to other references
 - Refine the charter; clearly identify the objective
 - Draft an outline of what we want the Handbook to look like and then we will conduct the research and determine if we
 have enough differentiation
 - Periodically out brief the PM Working Group on progress and to get assistance

 - Keep NDIA IPMD current on the changing environment and reporting requirements from CAPE
 - Provide industry comments on draft DIDs from CAPE
 - Consider Collaboration Meetings (NDIA-CAPE) resolve issues
- Assess the need for any additional IPMD documents regarding CSDRs
 - Will investigate / look at what educational materials may be needed for IPMD members to assist them in complying with the new Flexfile requirements
