• Data Pilot completion resulted in establishment of v3.0 metrics

• Code/Configure v3.0 metrics into EVAS software May – Aug 2017

- Impacted by 90 day Agency stand down on all IT projects
- Delay has impacted coding of metrics and adjustments to tolerance threshold
- Finalize data import protocols based upon flat file submittals

• Develop EVMS guideline/process testing protocols May – Aug 2017

- Establish metric testing process guidance
- Establish metric follow-up procedures
- Roll-out data driven compliance process across enterprise FY18

 - **Standardized Sampling Process** •
 - Internal Reporting/Coordination

Processes common throughout DCMA; will be consistent with other functional areas (not EVMS-specific)






