Before joining CSIS in 2003, Mr. Chao was a Managing Director and senior aerospace/defense analyst at Credit Suisse First Boston

from 1999-2003, where he was responsible for following the U.S. and global aerospace/defense industry. He remained a CSFB independent senior adviser from 2003-2006. Prior to joining CSFB, Mr. Chao was the senior aerospace/defense analyst at Morgan Stanley Dean Witter from 1995-1999. He served as the senior aerospace/defense industry analyst at Smith Barney during 1994 and as a director at JSA International, a Boston/Paris-based management consulting firm that focused on the aerospace/defense industry (1986-88, 1990-93). Mr. Chao was also a co-founder of JSA Research, an equity research boutique specializing in the aerospace/defense industry. Before signing on with JSA, he worked in the New York and London offices of Prudential-Bache Capital Funding as a mergers and acquisitions banker focusing on aerospace/defense (1988-90). Over the course of his Wall Street career, Mr. Chao's team was ranked #1 by *Institutional Investor* every

year eligible and he was on the *Institutional Investor* All-America Research Team every year eligible. He participated in 31 landmark aerospace/defense equity offerings/IPOs raising \$11.7 billion.

He is also a guest lecturer at the National Defense University and the Defense Acquisition University, has served on multiple Defense Science Board task forces, and was a member of the Defense Business Board (2010-2013). He was a member of the board of directors of KeyW Corporation (Nasdaq:KEYW) (2010-16) and Vistrionix Intelligence & Technology Solutions (2014-16). He is a holder of the right to use the Chartered Financial Analyst designation, holds Series 79/63 licenses, and holds a Top Secret security clearance.

Ms. Danielle Miller is the Director of Assessments and Investments within

the Office of the Under Secretary of Defense for Acquisition and Sustainment in the Office of Industrial Policy. Her goal is to secure robust and resilient supply chains to meet the warfighters needs. In her role, she provides direction, guidance, and oversight to the Defense Production Act (DPA) Title I and Title III program offices. She guides the development of the Industrial Base Analysis and Sustainment programs efforts to increase the skills of the industrial base workforce. She leads the assessment team's development of fulsome analyses of current and emerging risks and opportunities within the defense industrial base.

Ms. Miller gained extensive expertise in analysis and program evaluation in her prior roles with Cost Assessment and Program Evaluation (CAPE). As the Director of Readiness and Force Employment Division, she was responsible for leading CAPES' analysis of the Services' readiness portfolios and responsible for funding the DoD five-year readiness program. This included leveraging existing data sets and tools to develop intricate models of the aviation sustainment process. In addition, Ms. Miller was responsible for assessing Global Posture portfolio, and developing resourcing options prioritized by strategic alignment and operational relevance. Within CAPE, she also served as the Deputy Director of Joint Data Support Division. In this role she managed teams of analyst developing force structure and force employment data. She

led the establishment of archived historic deployment data, which continues to be used to support program evaluation.

Prior to her Civil Service Directorship positions, she worked in the private sector providing support to CAPE, the United States Air Force, and the Department of Labor. Ms. Miller also has spent time in the non-profit sector working for Special Olympics Florida and the Better Housing League of Greater Cincinnati. In each organization she effectively secured funding from a variety of foundations and local, state, and federal agencies.

She graduated from Florida State University with a M.A. in International Affairs and a B.S. from Wright State University in International Studies.

Sherrill holds a Bachelor's degree from the U.S. Naval Academy, a Master's degree in Global History from the London School of Economics and Political Science, and a Law degree from Georgetown University.

Sherrill sits on the House Armed Services Committee, the House Science, Space, and Technology Committee, and the House Education and Labor Committee.

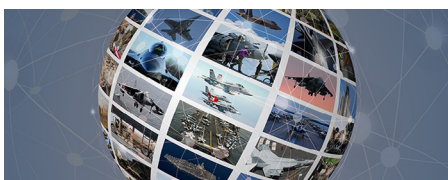

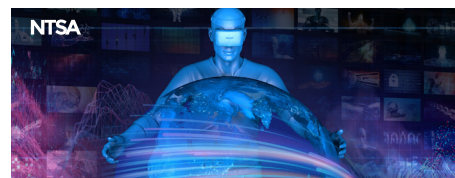
