 - Nations belonging to the NATO Alliance
 - Japan, Australia, or New Zealand
 - Nations with which the United States maintains a Reciprocal Procurement Agreement
 - Nations with which the United States Department of Defense has specifically asked the Association to conduct meetings and enhance communications on an industry-to-industry basis.
